Full application for alterations and extensions:

The clerk read out a written submission given to her by the member of the public and those present were given the opportunity to expand on the written statement. The Community Council was not given permission to publish that statement nor to share it with the County Council Planning Department.

Having listened to the submissions it was agreed to request an assurance that if granted that the driveway allows for sufficient parking and that it was made of a porous material to avoid any flooding issues. The Council would also support the neighbouring resident's concern about overlooking windows and the potential invasion of their privacy.

**9. Councillors' Reports**

9.1 Cllr. Barry Thomas:

Reported that Cllrs. Iwan Jones and Michael Bloor had informed him of their decision to resign as Community Councillors. The clerk would write to them to thank them for their service and inform the County Council of the vacant seats.

The hedgerow needed cutting between the B4545 junction, past the school towards Cae'r Sais - it was jutting out across the walk way and a hazard for children walking to and from school.

9.2 Cllr. Wyn Robertson asked for an update on the planning applications on Silver Bay Camp site.

9.3 Cllr. Susan Hanbury reported that there was strong smelling stagnant water by Pont Plascoch. The clerk would report it IOACC in the first instance.

9.4 Cllr. Tony Thompson asked whether the Community Council would support residents living on the outskirts of Pontrhydybont (by the Anchorage Hotel) by writing a strong letter to Openreach about the seriously ineffective broadband service in that vicinity. He was to provide further information for the clerk to be able to do that.
