- 7.1 Precept Financial Year 2026-27
There was detailed discussion about the financial forecasts to 31 March 2026 and the anticipated expenditure for the following year. This included the possibility of installing broad band in the hall etc. In any event, it was considered that the Council had sufficient reserves to request a smaller precept for 2026/27. It was therefore unanimously agreed to request the lesser figure of £6,000 for 2026/27 as any balance over that amount could be met from reserves.

Informed the Council that residents were very concerned that land by Pwll Pillo was being used for unauthorised land fill. Natural Resources Wales had already been informed – this was to be raised with them again.
